LPCCI POSITION DESCRIPTION

AREA DIRECTOR

POSITION OVERVIEW

The primary function of the Area Director is to manage and oversee LPCCI activities (Membership and Awards Programs, etc.) of each District in his/her Area through the appointed District Trustees. The Area Director is reportable directly to the LPCCI President and is a member of the LPCCI Board of Directors.

PRINCIPAL DUTIES

1. To be aware of LPCCI goals and objectives for the year and to develop district level plans with Trustees to fulfill those goals.
2. To ensure adequate efforts are made to fulfill district goals, the Area Director will maintain contact with, manage and supervise the activities of, provide guidance and advice to, each District Trustee in the area, and develop special activities and fundraisers.
3. To attend District Conventions and Cabinet Meetings within the area to represent LPCCI. A Trustee should attend those which cannot be attended by the Area Director, so that LPCCI is represented.
4. To be aware of and see that all Trustees adhere to LPCCI public relations policies.
5. To keep the LPCCI President informed about the activities of each Trustee within the area of jurisdiction, and on progress toward meeting the year's LPCCI goals.
6. To urge and secure a written quarterly report from each District Trustee and compile such reports into a written report to the LPCCI President prior to, or in attendance at, each quarterly Board Meeting.
7. To report any problems, breaches of policy, and situations of indiscretion immediately to the LPCCI President.
8. Neither expect nor receive any compensation for services rendered to LPCCI. LPCCI board approval is needed before incurring expenses on its behalf that are to be reimbursed.

ATTITUDE

An interest in seeing that CCI's mission to provide trained assistance dogs for people with disabilities is assisted by Lions, Lioness and Leos everywhere. An interest in seeing that LPCCI functions properly as the vehicle to help CCI through Lionism, and is able to make a substantial contribution to help CCI with its operating costs and need for puppy raisers. An awareness that nothing happens in an area or district without an effort.



LPCCI POSITION DESCRIPTION

TRUSTEE

POSITION OVERVIEW

The primary function of the Area Director is to manage and oversee LPCCI activities (Membership and Awards Programs, etc.) of each District in his/her Area through the appointed District Trustees. The Area Director is reportable directly to the LPCCI President and is a member of the LPCCI Board of Directors.

PRINCIPAL DUTIES

To promote and oversee an awareness and appreciation for the LPCCI and Canine Companions programs to clubs and individuals in the District. Have an interest in seeing that Canine Companions For Independence mission to provide trained dogs for individuals with disabilities is assisted by Lionism.

PRINCIPAL DUTIES

1. To oversee and locally manage the continued support of LPCCI by member clubs, life members and individual donors.
 - a. To arrange and provide demonstrations to the member and non-member Lion/Lioness, and Leo clubs in the District, or to have them arranged and provided by appointed Region Representatives.
 - b. To strive to increase club and individual memberships and donations, thereby increasing the overall support of the LPCCI program.
 - c. To promptly and appropriately make presentations - or arrange to have them made - of all awards, certificates, pins, banner plates, etc., to deserving donors.
 - d. To arrange for time on the agenda of District Cabinet Meetings and Conventions to provide updates on District LPCCI activities and/or make award presentations.
 - e. When called upon, to promptly "troubleshoot" LPCCI problems in the District (i.e., new addresses, delinquent member clubs, disbanded or life members, special requests, etc.)
 - f. To organize and promote at least one major LPCCI District fundraiser each year.
2. To work under the direct supervision of the Area Director. To notify the Area Director of any conflict in the District. To stay informed by attending LPCCI meetings held within your Area, and to provide quarterly written reports on your District LPCCI activities to your Area Director with a copy to the LPCCI office.
3. Provide assistance and guidance on policies and presentations, and obtain the literature and other materials they need from the LPCCI office. Keep updated on LPCCI information and activities so they can relay this information to clubs and bulletin editors. To attend Canine Companions functions whenever possible.
4. Neither expect nor receive any compensation for services rendered to LPCCI or any reimbursement for expenses incurred on its behalf.

LIONS PROJECT FOR CANINE COMPANIONS FOR INDEPENDENCE

OUTLINE FOR LIONS CLUB PRESENTATION



PREPARATION: Contact the Lions Club and make arrangements for a presentation. Arrange for a puppy raiser, graduate or breeder/caretaker to accompany you on your visit through the LPCCI office, or the CCI Regional Office or CCI Champion Group nearest you. Make sure the facility where the presentation is being made is aware that you will be bringing a dog. Confirm that the site is wheelchair accessible if you are bringing a graduate confined to a wheelchair. Make sure the facility has the proper equipment if you will be showing “Making Miracles Happen”. Reconfirm arrangements with the club at least one day prior to your visit.

Arrive early to allow time to set up the video, display literature, and generally get prepared for the presentation. Be sure to have on hand a supply of LPCCI brochures, CCI brochures, LPCCI Fact Sheets, LPCCI History, LPCCI Donations Opportunities, and the various application forms. Also have with you a supply of the items LPCCI sells as fundraisers. It is not necessary to distribute brochures to each Lion in attendance; have a supply available for those who wish to take them.

PRESENTATION: Begin by acknowledging club dignitaries and thanking them for allowing you to visit their club. Introduce yourself and the CCI person (and dog) accompanying you.

Give a brief outline of CCI and its purpose, mentioning its Mission Statement and four categories of dogs trained by CCI. You can glean this information from the enclosed CCI material: CCI Mission Statement, CCI National Fact Sheet, and CCI Frequently Asked Questions.

Follow with a brief outline of LPCCI, its Mission Statement and its origin. This information can be gleaned from the enclosed Suggested Basics for Doing an LPCCI Presentation to a Lions Club, LPCCI History and LPCCI Fact Sheet.

Then turn the meeting over to the puppy raiser, graduate or breeder/caretaker. He or she will tell about his/her experience as a puppy raiser, graduate or breeder/caretaker. These CCI representatives are the main focus of the program because they, through their association with CCI, can convince the club of the importance of supporting CCI. They should speak no longer than 10 - 15 minutes.

If a CCI representative is not accompanying you, show CCI’s DVD.

CONCLUSION: Follow the presentation with information on how the club can help. Thank them for any past support and point out that CCI is in continual need of financial support. CCI receives no government funding. Support is derived solely from grants, businesses, individuals, service clubs, and fundraising events. The cost of placing a CCI Team is over \$45,000. This covers breeding the pup, raising, training the dog, team training and follow up visits. There is no cost to the recipient.

Point out the various ways the clubs can support CCI through LPCCI. Refer to the Suggested Basics for Doing an LPCCI Presentation to a Lions Club and familiarize yourself with the listings on the LPCCI Donations Opportunities flyer so you can explain the benefits of the various types of donations. Point out the literature available. Have a supply of the Donations Opportunities flyers and accompanying applications available.

Then allow time for questions. You are not expected to know all the answers, and it is important that you not give misinformation. If you do not know the answer to a question, suggest finding out and getting back to the club. This is a good way of following up with a club after the presentation. You can also refer people to the CCI Internet website, to our LPCCI website, or to the nearest CCI campus.

The entire presentation should take no more than 20 to 30 minutes including time for questions and answers.

LIONS PROJECT FOR CANINE COMPANIONS FOR INDEPENDENCE

PRESENTATION BASICS TO A LIONS CLUB

There are two components to cover during a presentation. The first component is the Canine Companions for Independence (CCI) assistance dog program. The second component is the fact that the Lions Project for Canine Companions for Independence (LPCCI) is the official Lions foundation formed to provide financial and volunteer support to CCI through Lions clubs.

COMPONENT ONE: CCI

Their Mission Statement: "Canine Companions for Independence is a non-profit organization that enhances the lives of people with disabilities by providing highly trained assistance dogs and ongoing support to ensure quality partnerships."

CCI's assistance dog program is constantly evolving and improving. At the present time, CCI places four categories of dogs (see CCI Fact Sheets):

*Service Dogs *Hearing Dogs *Facility Dogs *Skilled Companions

When possible, request (through Lucille Hynes at the LPCCI office, CCI Region Offices, or CCI Chapter Groups) that a CCI graduate or puppy raiser accompany you on your club visit in order for them to illustrate how the dogs are trained and how they change peoples lives.

Show the CCI DVD "Making Miracle Happen" if a graduate or puppy raiser is not with you on the visit.

COMPONENT TWO: LPCCI

Our Mission: We are the officially sanctioned Lions foundation formed to provide financial and volunteer support to CCI through Lions clubs. (See LPCCI Fact Sheet)

DONATION OPPORTUNITIES

MEMBER CLUB 0-20 members = \$100 21-40 members = \$150 41-60 members = \$200 61-80 members = \$250 81+ members = \$300: This is a Club commitment to a suggested annual donation based on the number of Club members. A pledge reminder is sent annually. Clubs receive a Member Club banner patch, certificate, and subscription to LPCCI publications.

ABDUL AWARD \$100: This plaque commemorates Abdul, a black Labrador retriever who was the first Canine Companions for Independence assistance dog put into service. The story of his remarkable 14 years is on the back of the plaque. Translated, Abdul means "faithful servant." This award is a great way to say thank you to an individual who has performed outstanding service.

LIFE MEMBERSHIP \$300: Individuals truly become "life" members as the \$300 donation goes into a restricted fund and is kept there for the life of LPCCI. Only the interest is drawn from this account and donated to Canine Companions for Independence. Also included with your contemporary bamboo plaque comes a life member badge, detachable life member lapel pin, banner plate and subscription to LPCCI publications. Life Memberships can be paid in up to three \$100 installments over three years.

FAMILY LIFE MEMBERSHIP \$500: Two members of a family can buy a Family Life membership. This membership is treated the same as a life membership (see above).

DISTINGUISHED SERVICE \$300: A modern bamboo plaque commemorates your club's or an individual's commitment to helping others.

LPCCI FELLOWSHIP \$1,000: This is an unrestricted donation payable in one sum or over a four-year period of \$250 per year. Includes an elegant plaque, banner plate, lapel pin and subscription to LPCCI publications.

LPCCI VETERANS AWARD \$250 – BRONZE \$500 – SILVER \$750 – GOLD \$1000 – PLATINUM: Show a veteran in your life the appreciation they deserve with this stunning American flag plaque by making a charitable bronze, silver, gold or platinum donation in their honor.

PUPPY ADOPTION SPONSORSHIP \$500: Underwrites the cost of preparation, including vaccinations and temperament testing, for one Canine Companions puppy and travel expenses to its new home with a volunteer puppy raiser family. Sponsor receives a beautiful plaque with a commemorative 4" x 6" photograph of a sponsored puppy.

BREEDING PROGRAM SPONSORSHIP \$1,000: Helps offset the ongoing expenses of identifying, evaluating and obtaining new breeding stock and providing more litters of puppies that will be Canine Companions. The sponsor is acknowledged with a handsome wall plaque with a 4" x 6" picture of a litter of puppies.

KENNEL SPONSORSHIP \$1,500: Provides food and maintenance for one kennel of two dogs for the period of advanced training. This sponsor receives a plaque with 4" x 6" picture of the 2 dogs sponsored.

GRADUATION SPONSORSHIP \$2,500: Covers the direct expenses associated with one graduation ceremony, including hall rental, set-up fees, publicity and sign language interpreter. The sponsor is acknowledged in invitations, in the graduation program and during the ceremony. This sponsor receives a handsome plaque with a 5" x 7" horizontal photograph of the graduating class.

TRAINING SPONSORSHIP \$5,000: Sponsors the advanced training of one dog, including daily instruction, testing, field trips and supplies. The sponsor receives a glass engraved plaque with a 5" x 7" photograph of the sponsored dog.

TEAM SPONSORSHIP \$10,000: Helps offset the cost of breeding, raising, and training a Canine Companion through the time of placement with an individual with a disability. A Team Sponsor receives a commemorative 9" x 12" burl plaque, with a photograph of the sponsored dog and profile of the sponsored team.

REGIONAL FOLLOW-UP SUPPORT SPONSORSHIP \$25,000: Offsets the annual cost associated with the ongoing follow-up support for one region's graduate teams, ensuring the continued success of each graduate team. The annual Follow-up Support Sponsor for each region is acknowledged in news releases, Canine Companions for Independence newsletters, and each graduation program for one year, as well as receiving a handsome plaque with a photograph of the graduate teams.

- ❑ Lions have supported CCI since its very beginnings in Santa Rosa, CA in the 1970's.
- ❑ LPCCI (a Lions Foundation) was formally founded in 1983 (at CCI's suggestion) to better function as a significant provider of financial and volunteer support to CCI through Lions clubs.
- ❑ LPCCI consists of an all-volunteer board of directors, more than 75 volunteer representatives around the country, and one paid staff-person (the LPCCI National Administrator).
- ❑ LPCCI volunteer representatives provide presentations at Lions club meetings, district meetings and conventions, and at other service clubs and organizations, to increase public awareness of CCI's program and gain financial support, puppy raisers, etc.
- ❑ Lions and Lions Clubs support LPCCI through Club Memberships, Life and Family Life Memberships, Abdul and Distinguished Service Awards, LPCCI Fellowships, various sponsorships, and fundraisers.
- ❑ Many Lions serve as CCI puppy raisers, breeder-caretakers, Chapter group members, volunteers, and goodwill ambassadors spreading the word about CCI's program.
- ❑ Lions Clubs in 35 states across the nation donate to LPCCI.
- ❑ To date LPCCI has donated nearly \$3 million to CCI.
- ❑ LPCCI celebrated its 30th anniversary May 18, 2013.
- ❑ LPCCI needs volunteer representatives from every Lions district in every state, particularly in states where there is a CCI Regional Training Center. Please call LPCCI to learn more about it.

HISTORY

Everybody likes a good idea, but when a good idea becomes an organized effort, great things begin to happen.

The Lions Project for Canine Companions for Independence (LPCCI) started out that way - a good idea for Lions to help a fledgling organization in its mission to help people with disabilities.

Many Lions and Lionesses offered their help to CCI before 1981, both as individuals and through their clubs. The idea of district-wide support of the program began when Dick Woolf, Cabinet Secretary to the then District Governor Roger O'Donnell, invited CCI to send a speaker to District 4-C7's August 1981 Cabinet Meeting. Lion Don Webb, who had been personally involved in supporting CCI and wanted Lions to know about it, assisted in the presentation. The response was enthusiastic.

After many demonstrations with these highly trained dogs by CCI and Lion Don, Governor O'Donnell announced his decision to make CCI his district project for the fiscal year 1981-1982.

In 1982, at the urging of the late Lion Ty Tyree, articles were drawn up to establish a foundation similar in structure to the Lions Eye Foundation, with a network of coordinating trustees in every district, Life Members, Member Clubs, and other forms of support. After much perseverance, that set of plans became a reality and Lion Ty became the first president of the Lions Canine Companions Foundation (soon to be re-named the Lions Project for Canine Companions for Independence). Lion Ty also became the first Life Member.

District 4-C7 Governor John Robak continued the interest in CCI, making it his district project also, eventually becoming the foundation's second president. The Council of Governors of Multiple District Four (MD-4) sanctioned the foundation in 1983. From there, LPCCI grew to what it is today.

During the 1990's, as a result of its fundraising, LPCCI was honored by CCI with the naming of the CCI Northwest Regional Center Board Room and the Southwest Regional Center lobby area "The Lions Den". In June 2012, LPCCI celebrated the successful completion of a \$100,000.00 pledge to name the board room at the CCI Northeast Regional Center "The Lions Den".

On May 18, 2013, LPCCI celebrated 30 years of supporting CCI. During these 30 years, LPCCI raised close to \$3 million for CCI and continues to donate over \$100,000.00 each year.

Since its humble beginnings, LPCCI has grown in membership and support from Lions Clubs in just two states to 35 states across the nation. Currently LPCCI has 17 Area Directors and 68 Trustees working to create awareness and provide support for CCI. Lions and Lions Clubs contribute to LPCCI through Life Memberships, Club Memberships, awards, sponsorships, fundraising, puppy raising, and volunteering. Our goal is to have representation and support in all 50 states across the nation.
